To enter without downloading the app, mail a postcard including the sweepstakes name, your full name, contact phone number, and email to: Fifth Third Bank, PO Box 62837, Cincinnati, OH 45262. Postcard entries must be received by 5 p.m. EDT on February 15, 2019, in order to be eligible.

Only one (1) Entry per person will be accepted. If there is more than one account holder, the winner will be the primary account holder, as designated in Fifth Third's system of record. By submitting an Entry to the Sweepstakes, all entrants are affirming their agreement to the Official Rules. WHO MAY ENTER:

The Sweepstakes is open to all U.S. residents who are **at least 18** as of their entry date, and who have personal student loan debt. SUSPENSION / MODIFICATION / TERMINATION:
