To enter the Sweepstakes, during the Sweepstakes Period, log onto your Instagram account (or create a free account if you do not already have one) and comment "I'm in" on the Sweepstakes post. You must also follow @FifthThirdBank (collectively, an "Entry"). All Entry comments must be public in order for an Entry to be eligible.

Sponsor shall have no obligation to notify a potential entrant of an incomplete entry.

The time stamp on the Entry shall serve as the official timestamp for this Sweepstakes, provided that the Entry is public at the time of publication.

Entrants must be in compliance with Instagram Terms and Conditions, which can be found at help.instagram.com. Entrants acknowledge that the Sweepstakes is in no way sponsored, endorsed, administered by, or associated with, Instagram or Meta Platforms, Inc. Instagram is a registered trademark of Instagram, LLC.

By submitting an Entry to the Sweepstakes, all entrants are affirming their agreement to the Official Rules. Those who do not follow all of the instructions or abide by these Official Rules or other instructions of Sponsor will be disqualified. Sponsor reserves the right to void all Entries made through any robotic, automatic, mechanically programmed or similar entry duplication method and to disqualify any individual using such a method.

Sponsor and affiliated entities are not responsible for lost, misdirected, misplaced, stolen, tampered with, deleted, or invalid Entries. Assurance of delivery of Entries is the sole responsibility of the entrant. Sponsor reserves the right to permanently disqualify from this Sweepstakes any person it believes has violated these Official Rules. All Entries become the physical property of Sponsor and will not be returned.

WHO MAY ENTER

Entrants must be U.S. residents at least eighteen (18) years old as of the Entry date. The Sweepstakes is open to all U.S. residents who are at least 18 years of age as of their Entry date, excluding residents of the state of New York. Employees of Sponsor and its parent, divisions, affiliates, subsidiaries, advertising agencies or promotional partners associated with this Sweepstakes, and those living in the same household of such employees (whether legally related or not) are not eligible to enter or win a prize. Void where prohibited.

LIMIT

SELECTION OF WINNER

One (1) winner will be randomly selected from all Entries (the “Winner”). Winner will be notified by direct message on Instagram within five (5) business days following the close of the Sweepstakes Period. Notification is deemed to have occurred immediately upon sending of the direct message.

Winner may, in Sponsor’s sole discretion, be required to execute an affidavit of eligibility/release of liability/prize acceptance agreement (the “Prize Acceptance Release”) and return the Prize Acceptance Release before being eligible to receive his or her Prize. ODDS
